6.1 Manager of Administrative Services/Deputy Clerk - Community Grant Program Review 2023

The Manager of Administrative Services presented the report seeking the Committee's feedback on the Community Grant Program in advance of the 2024 intake period.

The Committee directed staff to amend the application form to ensure that applicants are required to select two (2) out of three (3) eligibility criteria in order to proceed with their applications. Additionally, the Committee directed that Tourism staff be asked to poll attendees at events in order to gather data on how many Elgin residents are in attendance, and that Committee discretion will be used when considering applications for events being held outside of Elgin County municipalities. Finally, the Committee directed that the grant program information be amended to include more information about the County's Strategic Plan and emphasize that events and programs should be in alignment with Council's strategic goals.
